In the demo of https://wifi.openwisp.io, we allow users to log in using their Facebook and Google accounts, in these cases we collect the minimum viable information (social network user ID, name, last name and email) to link the user's social media account to our database.

We do not use social media information nor try to access the information of the social network profile of the user in any other way, the sole purpose is to facilitate the log in.

LOG DATA

We want to inform you that whenever you visit our Service, we collect information that your browser sends to us that is called Log Data.
